What is ITEP?

ITEP utilises a visual communication and care planning approach known as node link mapping, which is used by trained key workers with their clients.

These psychosocial interventions have a number of positive outcomes in terms of clients' treatment experiences and reductions in illicit drug use. In 2007 the National Treatment Agency found that employing ITEP interventions resulted in:

- Clients experiencing a better rapport with their key workers.
- Increased levels of client participation in treatment.
- Higher rates of service retention and completion.
- Clients benefited from increased peer support.

In addition to mapping, the ITEP treatment manual contains brief interventions aimed at changing thinking patterns. Mapping is a visual medium for clarifying shared information between client and key worker. It helps clients to look at the causes and effects of their thinking and also assists in problem solving.

Who Should Attend:-

1. Plan and prepare therapeutic group activities
2. Prepare and support individuals through therapeutic group activities
3. Evaluate agreed therapeutic group activities
